THE CITY OF NEW YORK ANNOUNCES SALE OF GENERAL OBLIGATION REFUNDING BONDS

The City of New York (the "City") announced the sale of approximately \$800 million of tax-exempt fixed rate General Obligation refunding bonds.

The City received approximately \$251 million of retail orders for the bonds during the two-day retail order period preceding yesterday's sale. Stated yields on the bonds ranged from 0.20% in 2016 to 2.65% in 2033 for a premium coupon bond and 3.09% in 2035 for a discount bond. The refunding bonds were sold via negotiated sale through the City's syndicate, led by book-running senior manager Jefferies with BofA Merrill Lynch, Citigroup, J.P. Morgan, Morgan Stanley, and Siebert Brandford Shank & Co., L.L.C. serving as co-senior managers.

The ratings for New York City General Obligation Bonds are Aa2 from Moody's Investors Service, AA from Standard & Poor's, and AA from Fitch Ratings.
