




# Total Portfolio Returns: March 31, 2011




## **Portfolio Asset Allocation: March 31, 2011**




#### Performance Attribution: Total Plan – Quarter Ending March 31, 2011






# **Total Equity Asset Allocation: March 31, 2011**




#### **Total Domestic Equity Returns vs Russell 3000 Index**




## **EAFE Markets Returns vs MSCI EAFE Index**






## **Total Fixed Income Asset Allocation: March 31, 2011**



#### Structured Fixed Income Asset Allocation: Quarter Ending March 31, 2011




## Structured Returns vs NYC Core + 5 Index





#### Through March 31, 2011

- Effective 4/1/03 the name of the Core +5 benchmark index provider was changed from Salomon to Citigroup.
- Effective 7/1/09, the Core+5 program was restructured.
  - The U.S. Gov't sector benchmark Index was changed from the Citigroup Core+5 Treasury/Gov't Sponsored Index to the Citigroup Core+5 Treasury/Agency Index.
  - The Corporate and Yankee sectors were combined to form the new Investment Grade Credit sector. The benchmark for the new combined sector is the customized Citigroup Credit Index. For historical performance purposes, the old Corporate sector Index is linked to the new Credit sector Index.
  - There were no changes to the Mortgage sector Index.
  - The total Core+5 results and benchmark returns combine the three sectors. Historical total Core+5 returns continue to include the old Corporate and Yankee sector returns.

- Plan Return at Policy Weights: the return of the Total Plan assuming actual Asset Class results were maintained at target (Adjusted Policy) weights. Figure = (Return of Asset Class 1\* Target Weight) plus (Return Of Asset Class 2\* Target Weight) plus (.....)
- Allocation Effect = Total Plan Return minus Plan Return at Adjusted Policy Weights.
- **Management Effect =**Custom Benchmark (Adjusted Policy Index) Return minus Plan Return at Adjusted Policy Weights This illustrates how the Managers have added or removed value based on their Security Selection decisions.

#### • Policy Index = Custom Benchmark

The "policy index" is a custom benchmark representing the weighted average return of the benchmark indexes for each major investment program. Weights may reflect an adjustment of actual policy for outstanding commitments for new or revised programs, such as for private market programs, which are invested gradually, or for any new or updated program requiring the completion of RFPs and contracts. The policy index/custom benchmark is calculated monthly based on adjusted policy weights at the beginning of each month. The indexes and most recent adjusted policy weights are as follows: **U.S. Equity**: Russell 3000 \* 50% International Developed (EAFE) Markets: MSCI EAFE \* 13% International Emerging Markets: MSCI Emerging Markets \* 4% **REITs**: Wilshire Real Estate Securities \* 3% **Domestic Fixed Income**: NYC Core +5 \* 21% **TIPS**: Barclays Capital U.S. TIPS \* 3% Enhanced Yield: Citigroup BB&B \* 6%

#### Page 8 - Management Effect - Asset Class Breakdown

This chart aims to break down the Management Effect shown on the Performance Attribution pages. The aim of the Page is to show the asset classes where Managers are either out performing or under performing their benchmark and to show the basis point effect that this is having on Plan performance.

#### Page 17 – Structured Fixed Income Asset Allocation

- Value Added By Sectors: This disaggregates out-performance or under-performance by Asset Allocation and Management Effect.
- Implied Policy = Retirement's System Asset Allocation.
- Implied Return = Benchmark Return
- **Allocation** = the Contribution to Performance resulting from an overweight or underweight to an asset class. *E.g. an underweight to an Asset Class that under-performs rests in a positive Allocation Effect and vice versa.*
- **Management** = Contribution to Performance from security selection versus the Benchmark, e.g., If the managers Actual Returns are higher than the Implied Return there will be a positive Management Effect.
