2. Performance Track Record

As of June 30, 2025, at a minimum, the recommended product must:

- a. Have, at a minimum, a five-year live track record. It is strongly preferred that the return composite is calculated in accordance with CFA Institute Global Investment Performance Standards ("GIPS")-required methodologies or other appropriate methodologies. Note that GIPS-required methodologies refer to both the calculation of returns and the creation and maintenance of the composite.
- b. Have a minimum product AUM of \$500 million.
- c. Have total firm AUM in Systematic products of at least \$10 billion.
- d. Proposers may link track records from two firms if they meet CFA Institute standards for portability.
