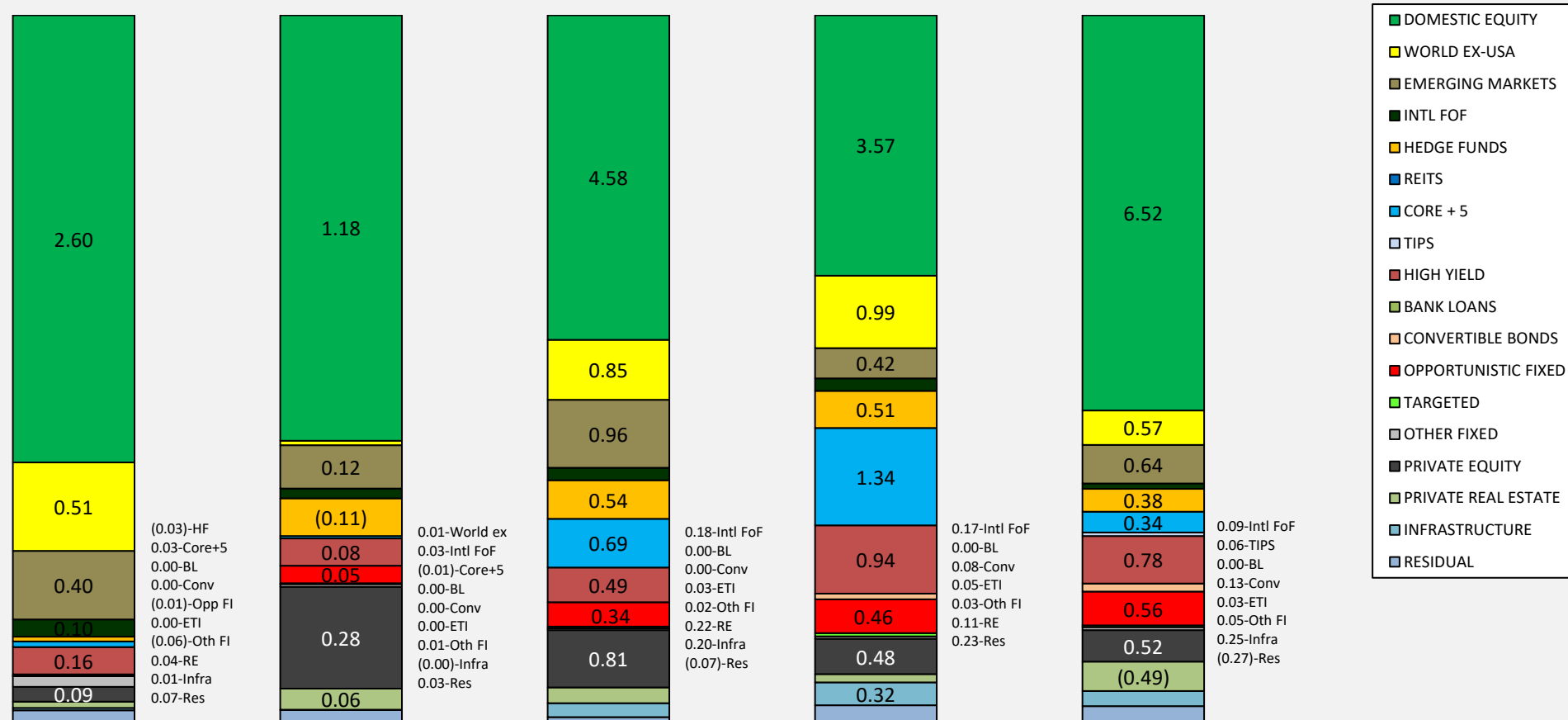

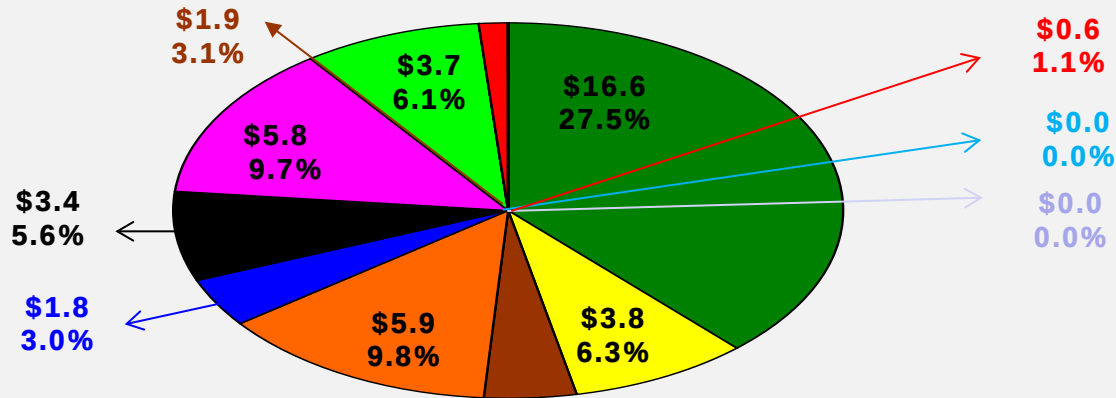

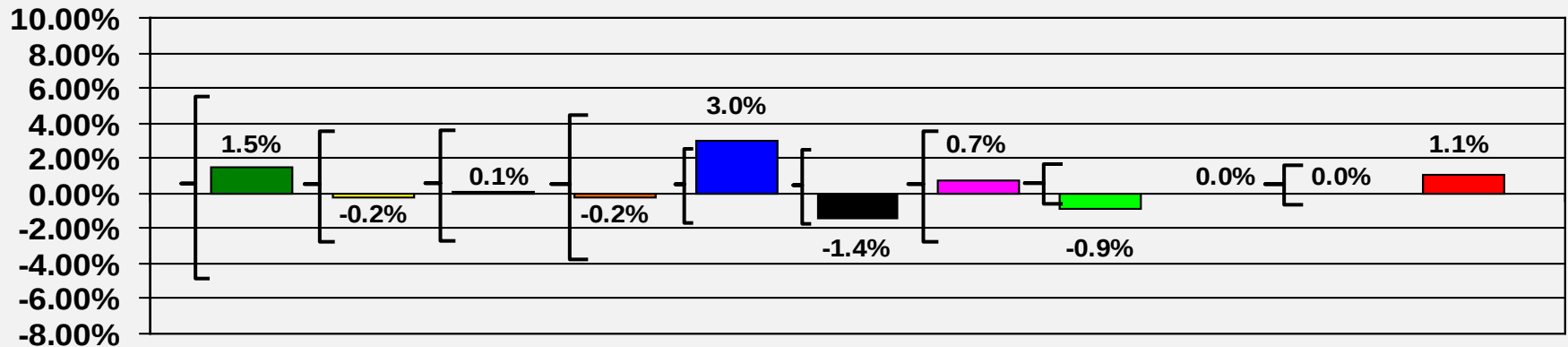

Relative Mix to New Policy Weights

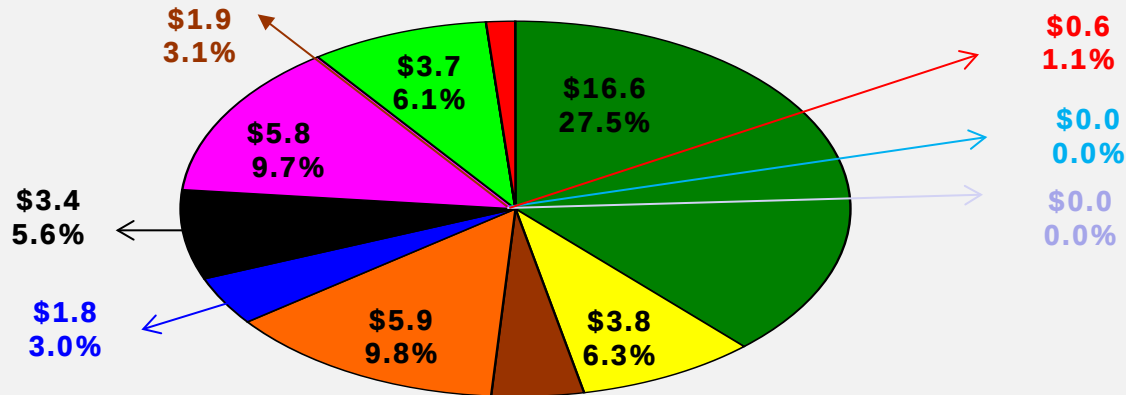

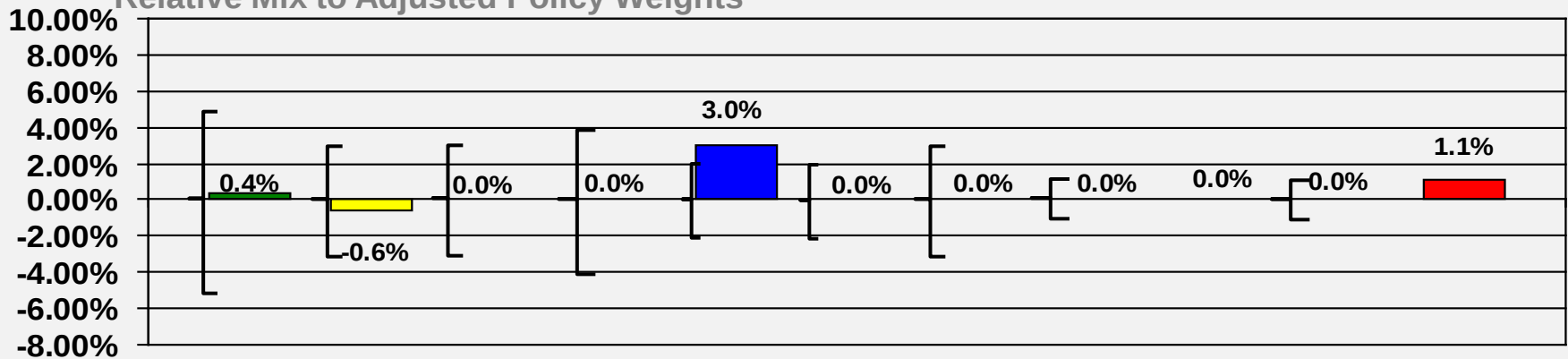

Relative Mix to Adjusted Policy Weights

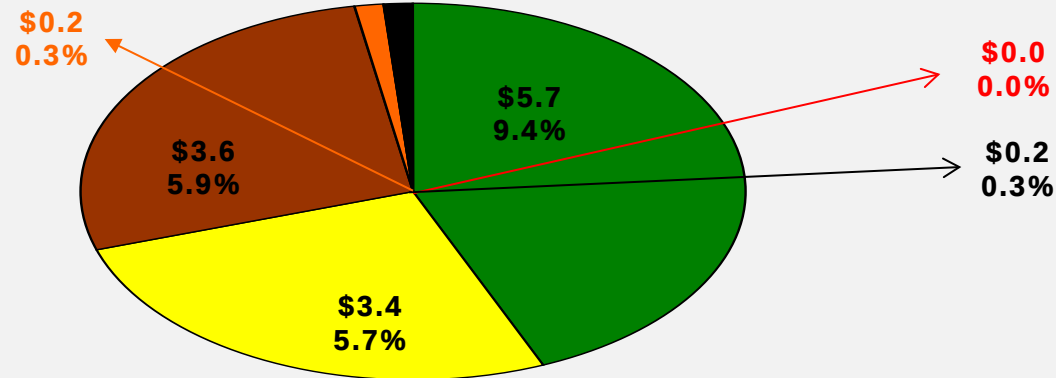

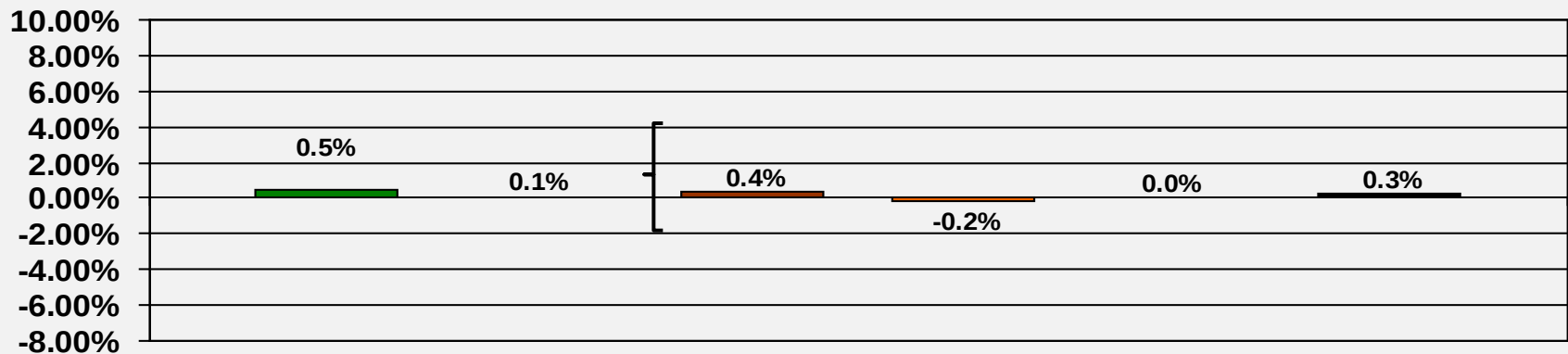

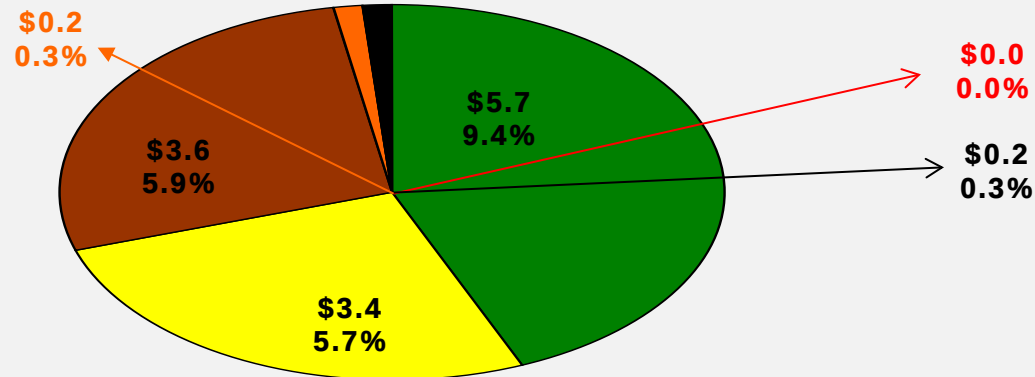
Relative Mix to New Policy Weights



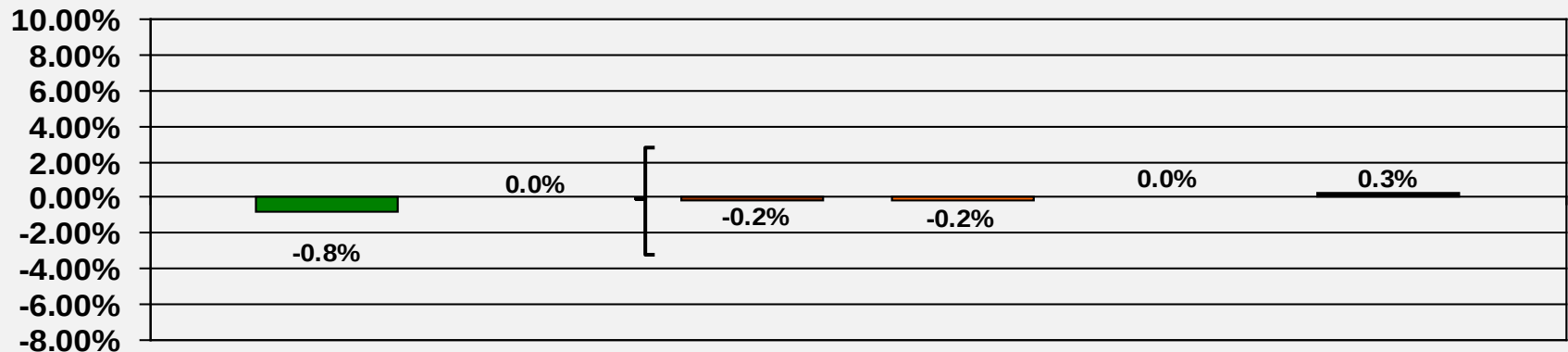

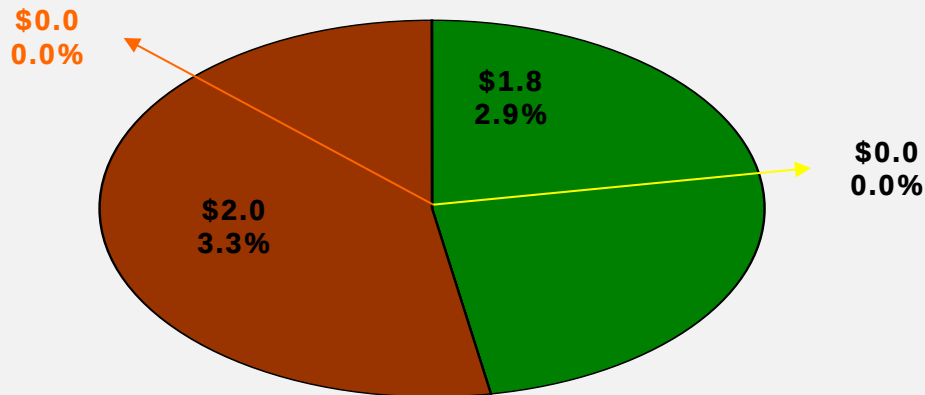
Relative Mix to Adjusted Policy Weights

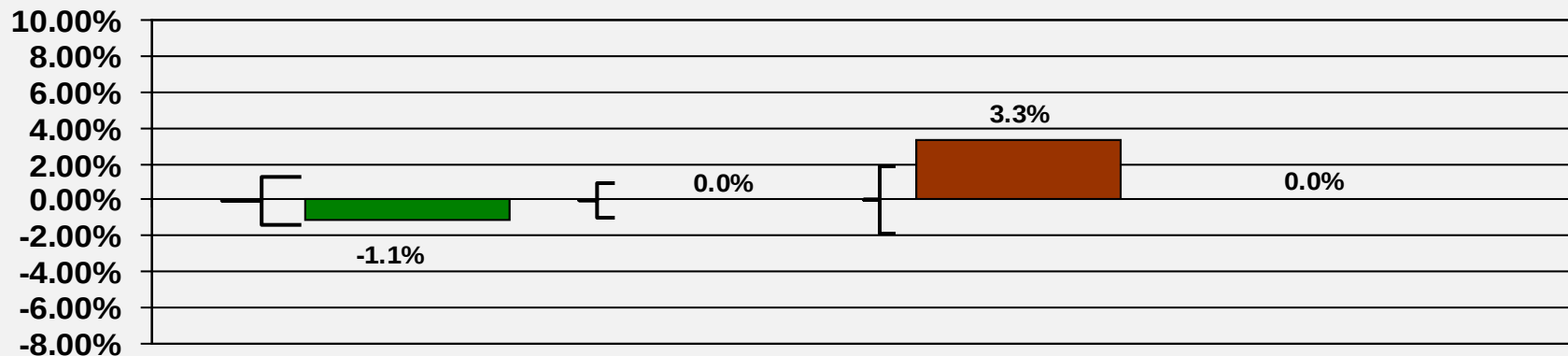

Adjustments to Long-Term Asset Allocation

- 1) Private Equity
- 100% of active weights in Private Equity will be offset to Domestic Equity.
- 2) Private Real Estate
- 50% of active weights will be offset to US Equity, 10% of active weights will be offset to US Treasuries, 20% of active weights will be offset to Investment Grade Corporates, and 20% of active weights will be offset to Mortgage Backed Securities.
- 3) Infrastructure
- 27% of active weights will be offset to US Equity, 18% of active weights will be offset to Developed Ex-US Equity, 5% of active weights will be offset to Emerging Markets Equity, 15% of active weights will be offset to US Treasuries, 20% of active weights will be offset to Investment Grade Corporates, and 15% of active weights will be offset to Mortgage Backed Securities.
- 4) Opportunistic Fixed Income
- 10% of active weights will be offset to US Treasuries, 20% of active weights will be offset to Investment Grade Corporates, 20% of active weights will be offset to Mortgages Backed Securities, and 50% of active weights will be offset to High Yield.
- 5) Hedge Funds
- 27% of active weights will be offset to US Equity, 18% of active weights will be offset to Developed Ex-US Equity, 5% of active weights will be offset to Emerging Markets Equity, 10% of active weights will be offset to US Treasuries, 20% of active weights will be offset to Investment Grade Corporates, and 20% of active weights will be offset to Mortgage Backed Securities.

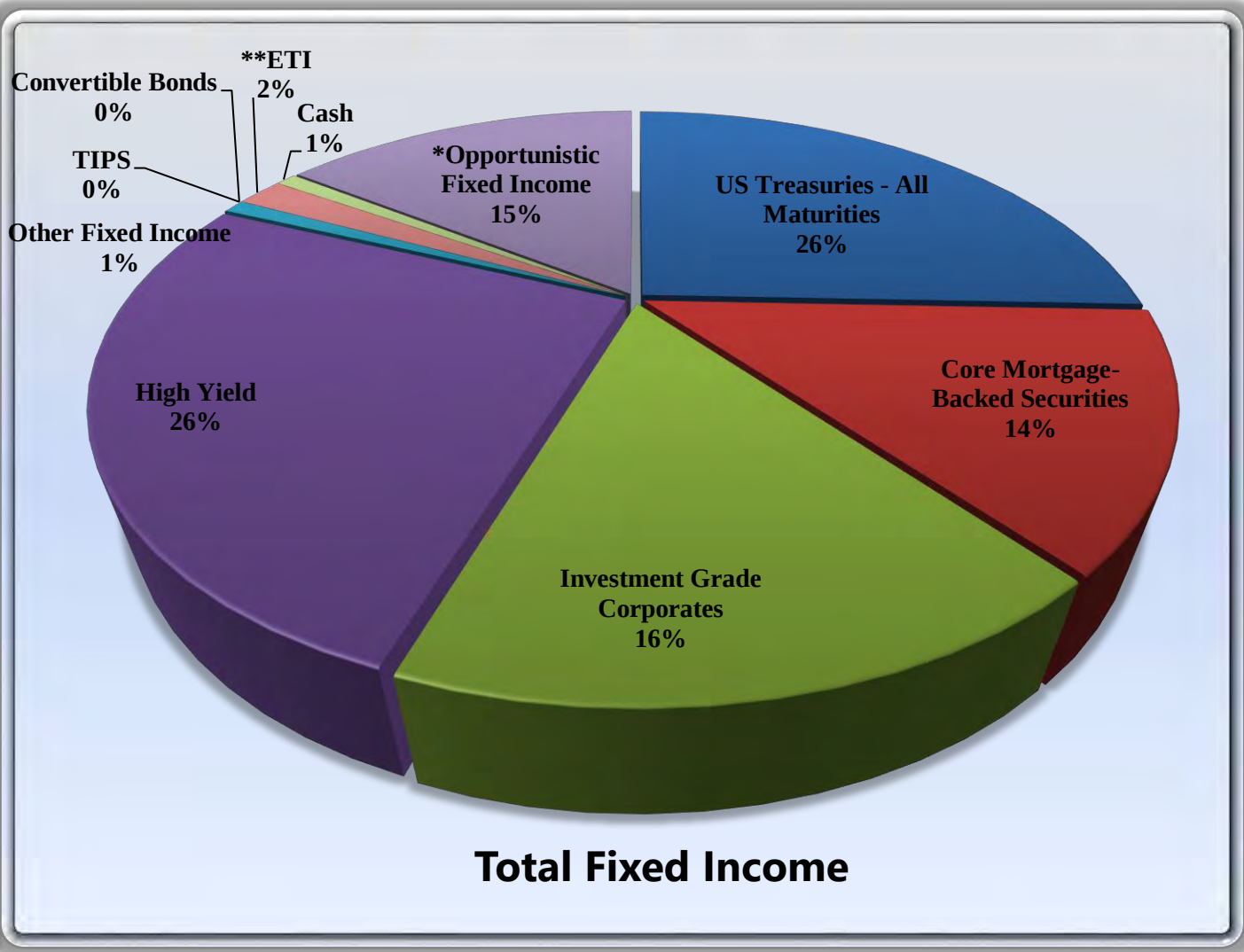
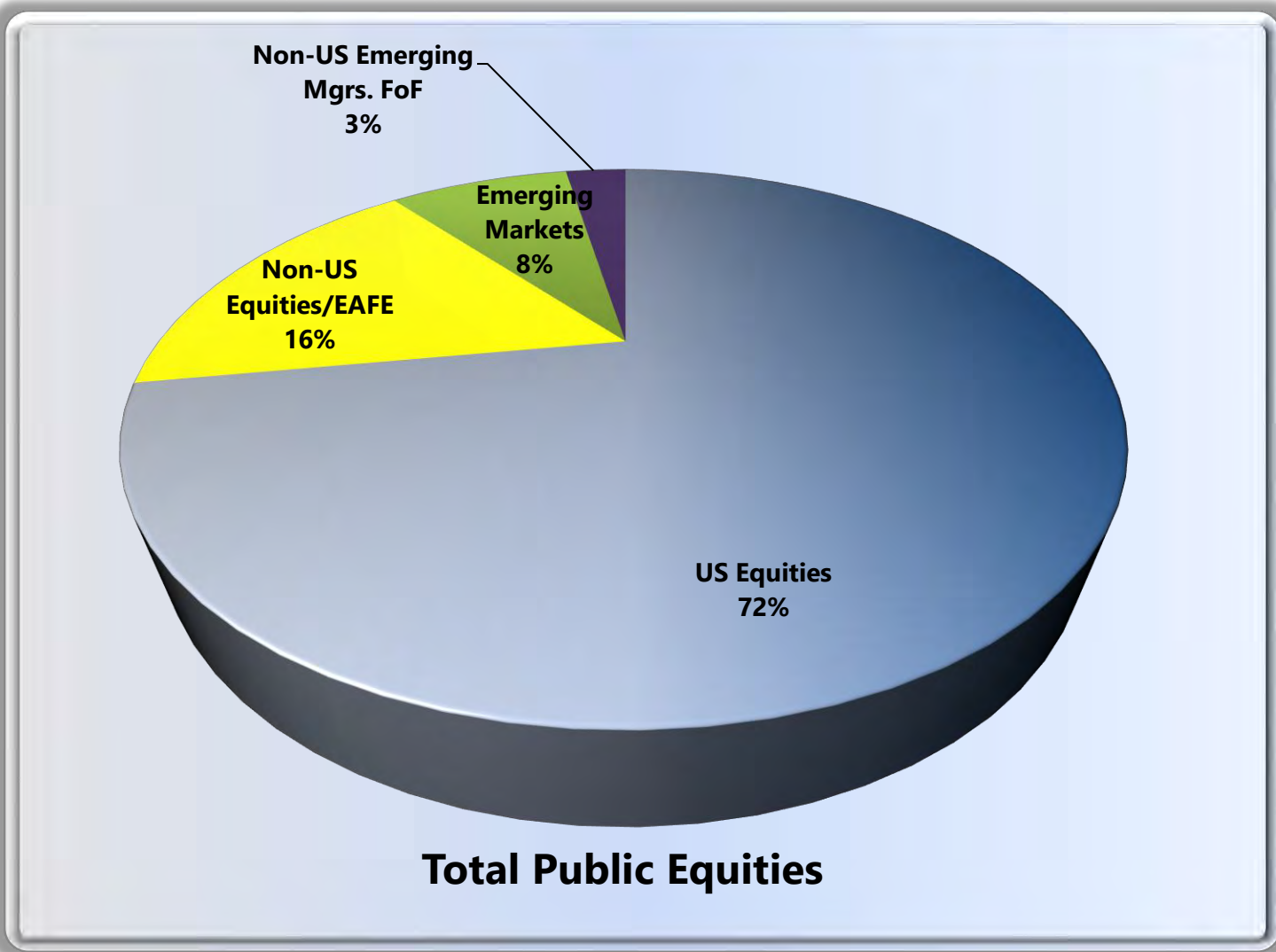

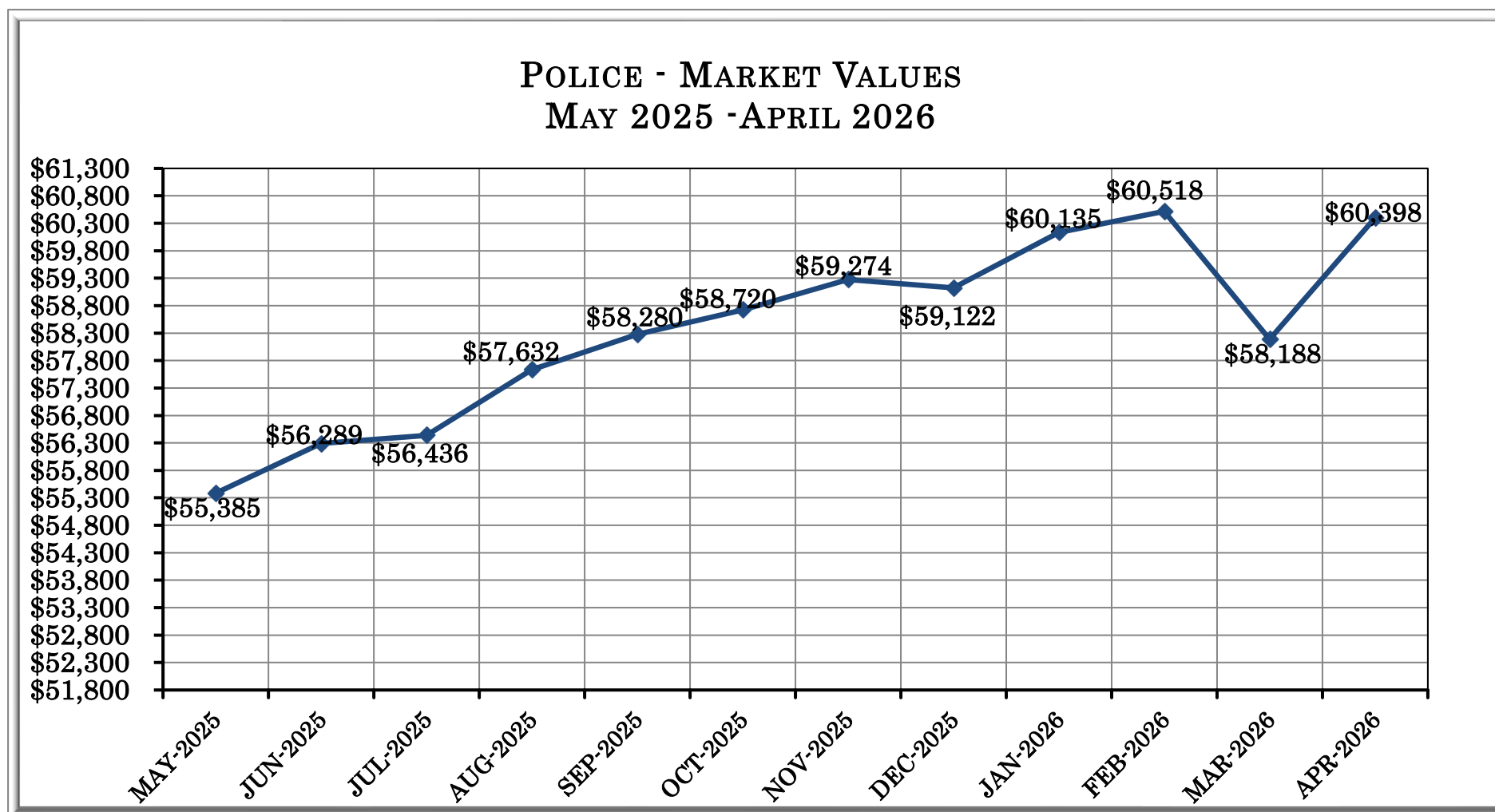

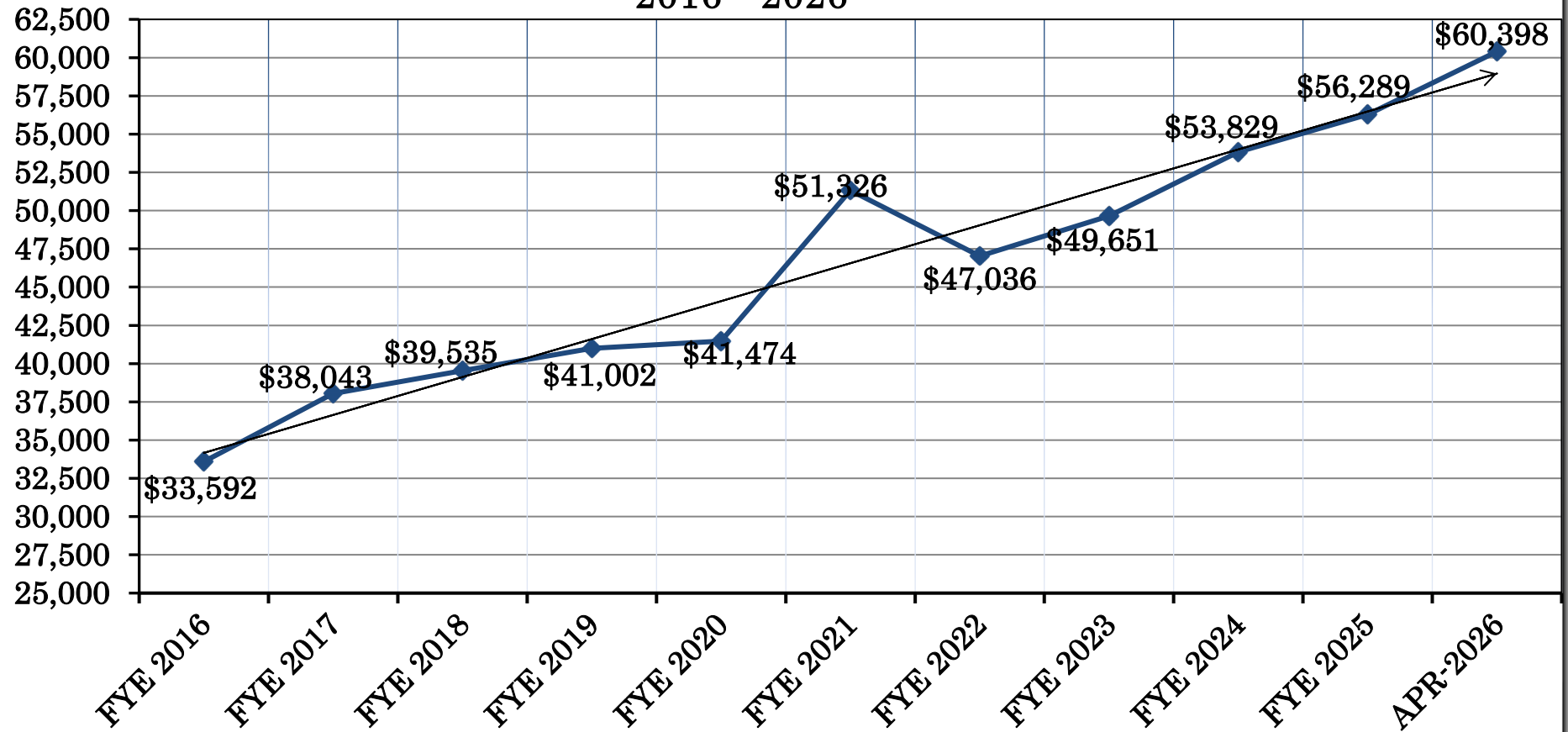
NYC POLICE DEPARTMENT PENSION FUND

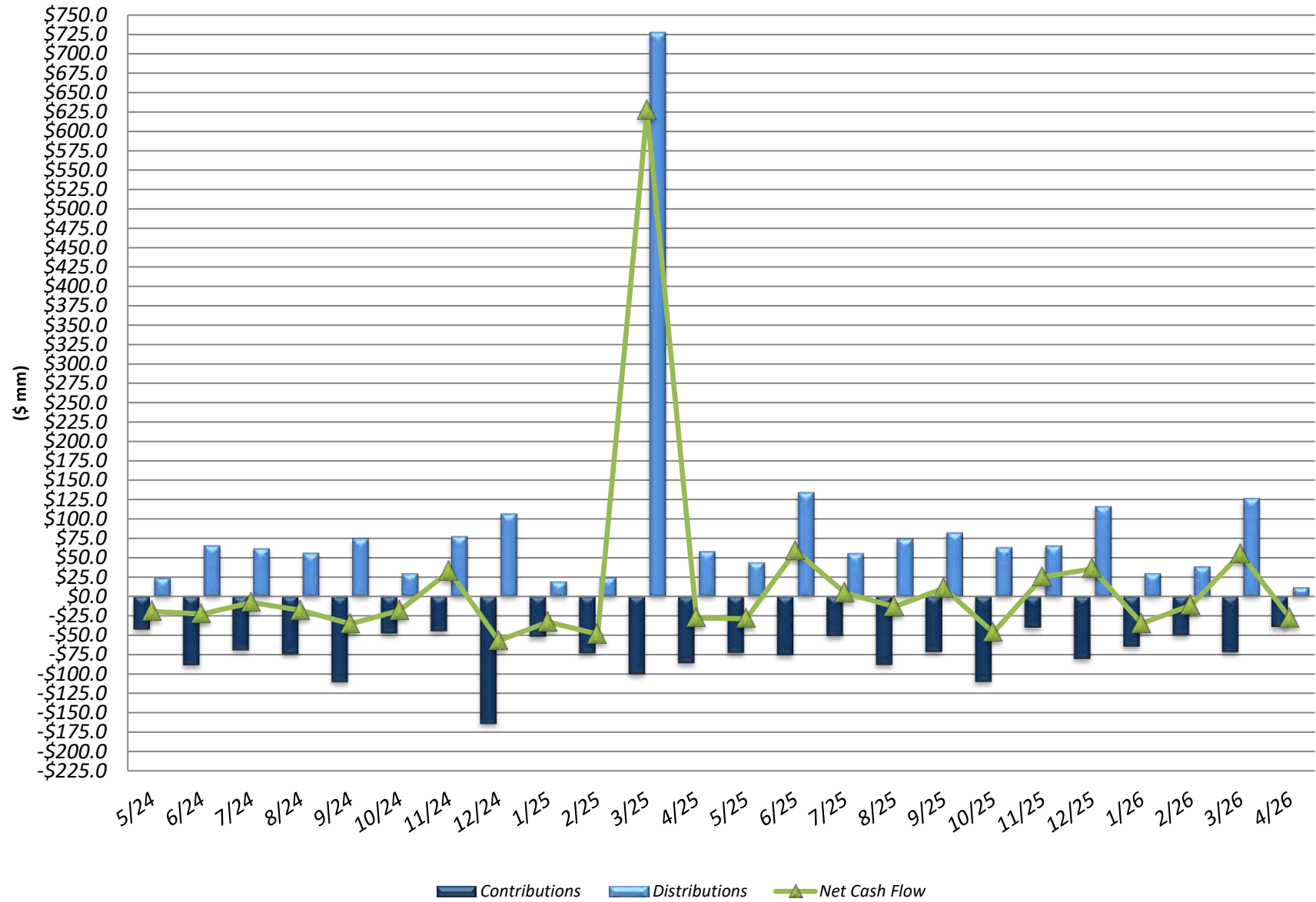

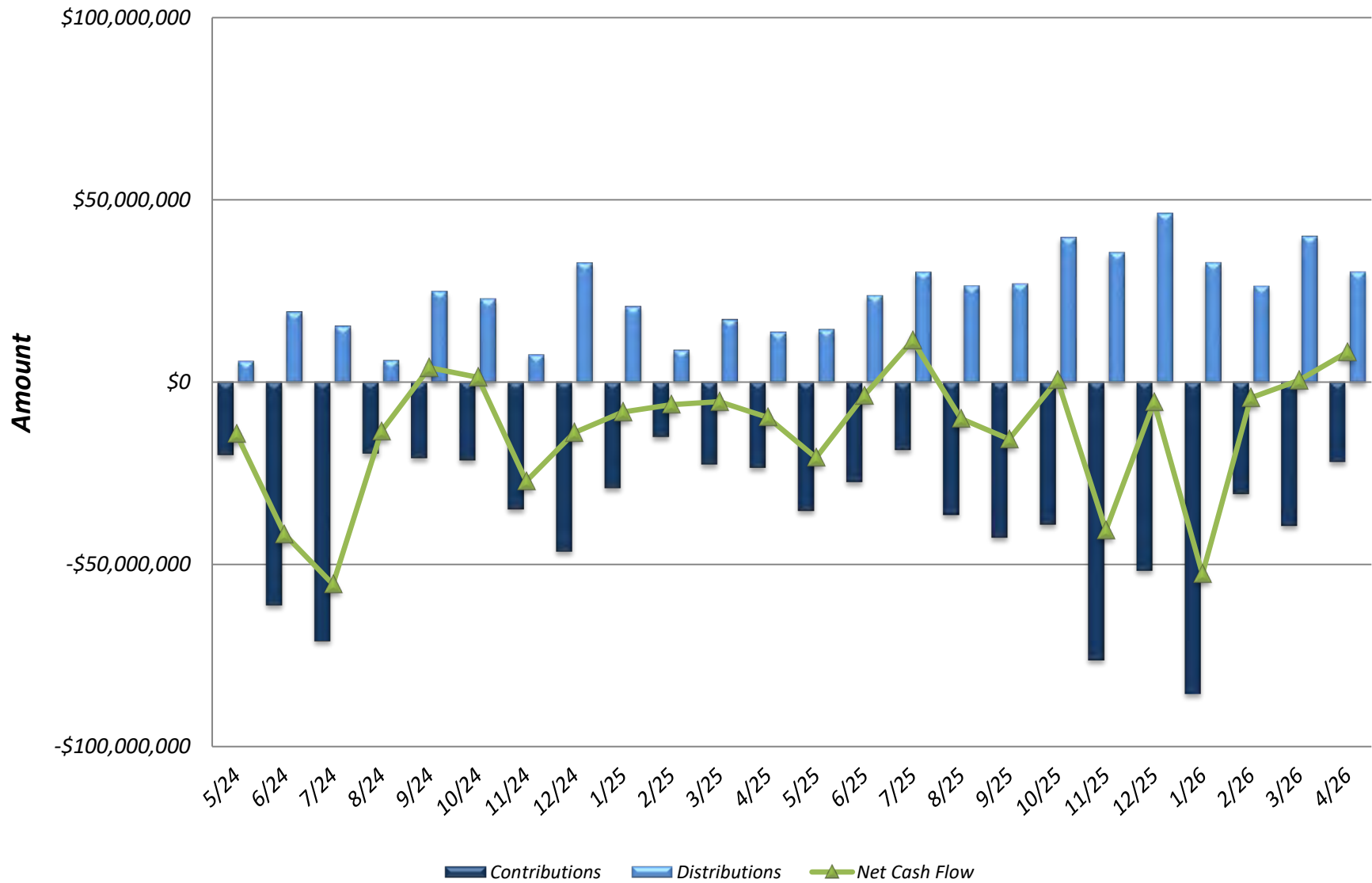
