#### City of New York Employees' Retirement System Second Quarter 2021 Summary

**General Economic and Market Conditions:** U.S. GDP grew at a 6.5% annual rate in 2Q21 and regained the level last seen in February 2020, before the COVID pandemic spurred a global shutdown in economic activity. Our focus during the pandemic has been on the level of economic indicators— GDP, employment, unemployment, consumer spending, imports and exports, and personal income. Traditional measures such as annualized GDP growth lost meaning around the plunge and sharp recovery that defined the shutdown and reopening experience. Reaching the previous level of real GDP is a major milestone; now, GDP growth will regain some meaning as a way to track economic progress. Other key indicators like employment have yet to regain their pre-pandemic levels. In fact, employment has been the measure that took the greatest hit and has the furthest to go before claiming full recovery. We lost over 22 million jobs in the U.S. in March and April of 2020; while we have gained 15.5 million back, that's still almost 7 million short. The lost jobs were spread across many industries, but the deepest losses and the greatest deficits left to recover are in lower-paid sectors with concentrations of hourly jobs, including hospitality and travel-related industries.

The gains in GDP in 1Q and 2Q were startling and robust, yet still a bit less than economists expected. The Federal Reserve issued a forecast of 7% growth for the year in June 2021, but the 1Q figure was revised down to 6.3%. Growth in 3Q is expected to be stronger than 2Q, but consensus expectations for the year are coming down from 7%. Restocking depleted inventories was expected to be the main driver of growth this year, along with incredibly robust spending by consumers, but supply bottlenecks led to an actual decline in private inventory investment in 2Q, particularly in retail goods. Economists now estimate that in the second half of the year, inventory building is expected to account for as much as two-thirds of GDP growth.

Supply bottlenecks are really the story of the year for many markets in the global economy, both in goods such as building materials, commodities, and auto parts (such as vital computer chips), and in labor for a number of industries, in particular those originally hit hardest like hotels, restaurants, retail, and travel. The stories told by businesses unable to fill multiple open positions contrast sharply with the 7 million job deficit. So what gives? Fueling personal consumption demand has been a singular economic period where the steepest recession in terms of job losses and GDP decline in 70 years was accompanied by NO decline in total personal income. In a normal downturn, as individuals lose jobs and companies close their doors, spending sags as consumers and companies cut back. Unprecedented policy actions to support both individuals and businesses kept incomes in aggregate from falling at all, yet shutdowns held back supply in the face of almost no decrease in demand, at least for goods like building supplies, technology, communications, and computer services.



These kinks in supply have led to a spike in headline inflation: the year-over-year Consumer Price Index came in at 5.4% in June, while the much-more-volatile Producer Price Index shot up 19.5% compared to June 2020. After complete or partial shutdowns around the globe, many industries cannot simply restart production and build supply to meet surging demand instantaneously. Producer prices had been tumbling for more than a year prior to the pandemic, and then suffered another shock with the almost-forgotten plunge in energy prices in 1Q20 as Saudi oil producers entered into a price war to establish global energy supply discipline. The price of building materials, specifically timber, became the metaphor for inflation fears, reaching the point of commentary by none other than the chairman of the Federal Reserve. As incomes were maintained and interest in home renovation soared during the pandemic, demand for lumber surged while product from lumber mills was constrained first by total shutdowns and then production processes limited by social distancing protocols. Timber prices shot up over 300% by the start of June 2021, reaching an all-time high of \$1,515 per thousand board feet. As production caught up and demand finally eased, prices have since fallen by over \$1,000 and are back at 2018 levels (but still up 200% from spring 2020). Such volatility may be extreme, but timber really may be the appropriate metaphor for transitory price increases that will work through many industries and labor markets in the U.S. and global economies throughout 2021 and into 2022.

**Total Fund Performance:** For the quarter ended June 30, 2021, the Fund returned +5.38%, twenty eight basis points above the Policy Target return of +5.10%. Over the trailing year, NYCERS has earned a return of +27.01% versus the Policy Target return of +26.34%. Over three years, the total Fund has returned +12.28% annualized. Over the trailing five years, the Fund has gained 11.76% annualized. The trailing 10-year return is +9.34% annualized.

Total Fund Assets: The Fund's assets totaled \$86.0 billion as of the end of the second quarter of 2021.

**U.S. Equity:** The total domestic equity portion of the NYCERS Fund returned +7.68% for the quarter, below the +8.24% return of the Russell 3000 Index. For the trailing year, NYCERS outperformed the index, returning +45.23% versus +44.16% for the index. The Fund is below the benchmark over the trailing three, five and ten year periods.

In Large Cap, the Fund underperformed the Russell 1000 Index, returning +7.94% versus the Russell 1000's return of +8.54% during the second quarter. The Fund's one year return of +43.88% outperformed the +43.07% return of the Index. The Fund is below the benchmark over the trailing three year period.



In Small Cap, the Fund returned +4.39%, above the Russell 2000 return of +4.29% for the quarter. The Fund's one year return of +61.70% underperformed the +62.03% return of the Index. The Fund is ahead of the benchmark over the trailing three year period.

**Developed International:** For the quarter, the Fund's Non-U.S. Developed Equity composite returned +5.82% (excluding NYCERS' historical non-U.S. Environmental manager), outperforming the Custom MSCI World ex-US Benchmark by 30 basis points. The Fund returned +40.27% for the trailing one year period, above the return of the benchmark (+34.82%). The Fund is above the benchmark over the trailing three, five, and ten year periods.

**Emerging Markets Equity:** The Fund's active emerging markets equity composite returned +5.31% in the quarter, outperforming the +5.05% return of NYCERS custom MSCI benchmark. The active portfolio outperformed the passive one for the quarter. The one year return for the active emerging markets composite is +54.18%, outperforming the +49.44% return for the benchmark. The active emerging markets equity composite is above the benchmark over the trailing three, five, and ten year periods.

**Core Fixed Income:** The composite of the Fund's core program returned +2.09% during the quarter, while the NYCERS Custom Structured Index returned +1.93%. For the past year, the core composite has returned -0.04%, while the benchmark's return is -0.39%. The Fund is below the benchmark over the trailing three and five year periods and ahead of the benchmark over the trailing ten year period.

**TIPS:** The Fund's TIPS composite delivered a +3.42% return in the quarter, above the +3.25% return for the Bloomberg Barclays Capital US TIPS Index. Over the past year, the Fund's TIPS managers have returned +6.46%, underperforming the benchmark's return of +6.51%. The Fund is below the benchmark over the trailing three year period, even with the benchmark over the trailing five year period, and ahead of the benchmark over the trailing ten year period.

**High Yield:** In high yield, the Fund's managers returned +2.80% for the quarter, while NYCERS High Yield Custom Benchmark posted a lower return of +2.74%. The Fund outperformed the custom benchmark over the past year, returning +15.45% as compared to the benchmark's return of +15.34%. The Fund is ahead of the benchmark over the trailing three, five, and ten year periods.

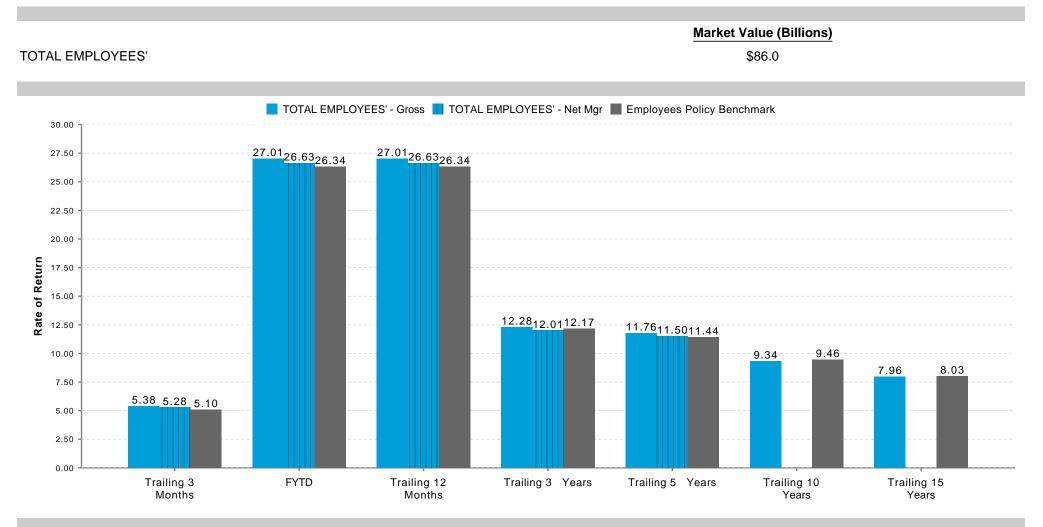
**Convertibles:** The convertible portfolio returned +2.10% in the quarter, below the +3.77% return of the ICE BofA All US Conv Ex Mandatory Index. Over the past year, the convertibles portfolio has returned +22.93%, underperforming the +48.00% return for the benchmark. The Fund underperformed the benchmark over the trailing three, five, and ten year periods.



**Opportunistic Fixed Income:** The opportunistic fixed income composite returned +4.86% over the second quarter, outperforming the blended benchmark of 50% JP Morgan Global High Yield / 50% Credit Suisse Leveraged Loan Index - Plus 300 bps (+2.83%). The Fund returned +21.77% for the trailing one year period, above the return of the blended benchmark (+17.35%). The Fund is below the blended benchmark over the trailing three, five, and ten year periods.

**Alternatives:** For the quarter, the Private Equity portfolio had approximately \$6.5 billion in invested capital, representing roughly 7.6% of the Total Fund. The Private Real Estate portfolio had approximately \$4.3 billion invested, accounting for roughly 5.1% of the Total Fund. The Infrastructure portfolio had approximately \$997 million invested, or 1.2%. Performance is reported separately by NYCERS' Private Equity and Real Estate consultants.

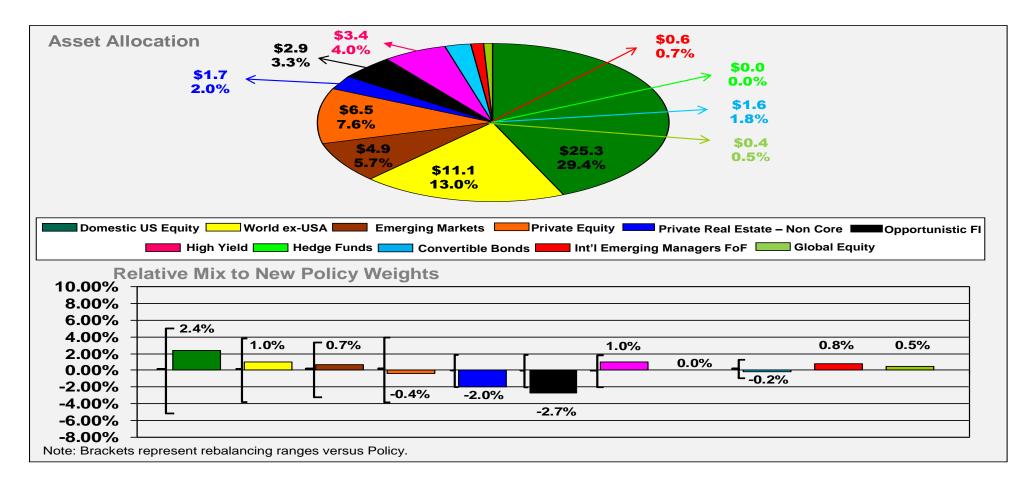

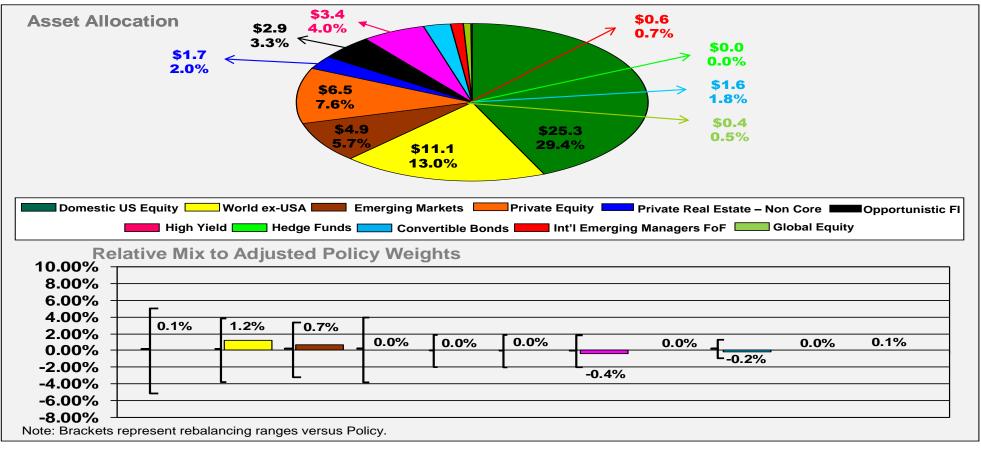


#### **Portfolio Asset Allocation – Growth**





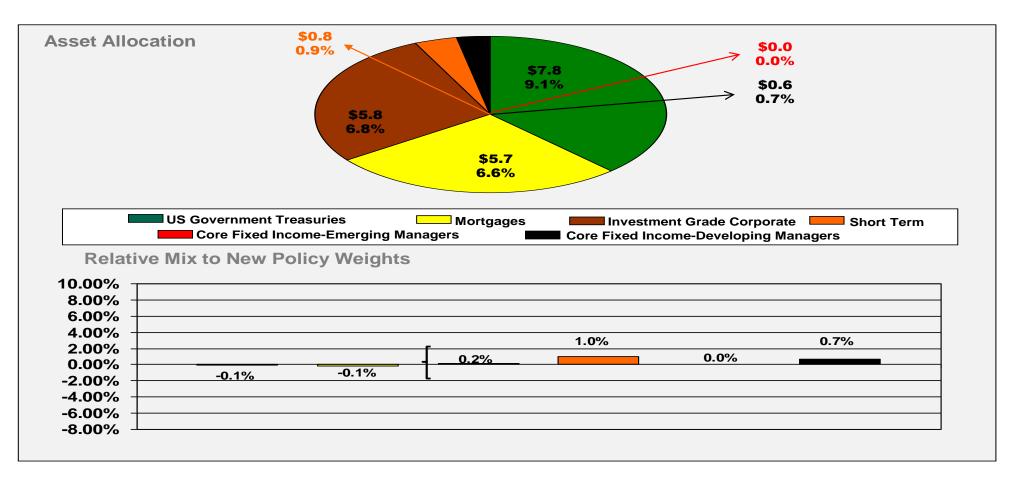
#### **Portfolio Asset Allocation – Growth**

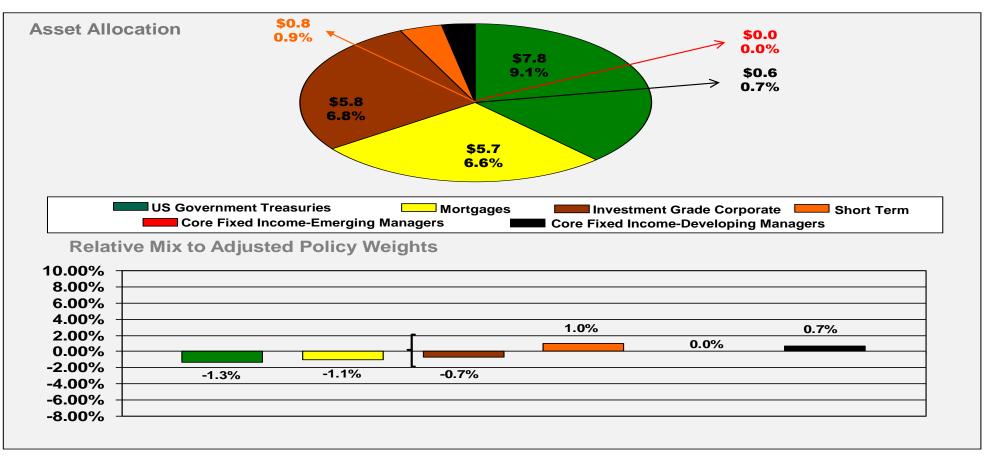


## **Portfolio Asset Allocation – Deflation Protection**





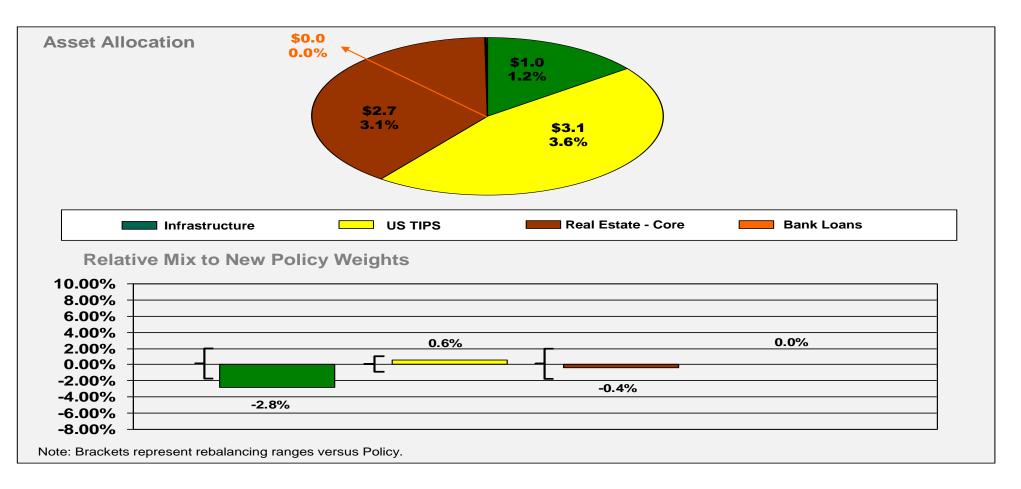

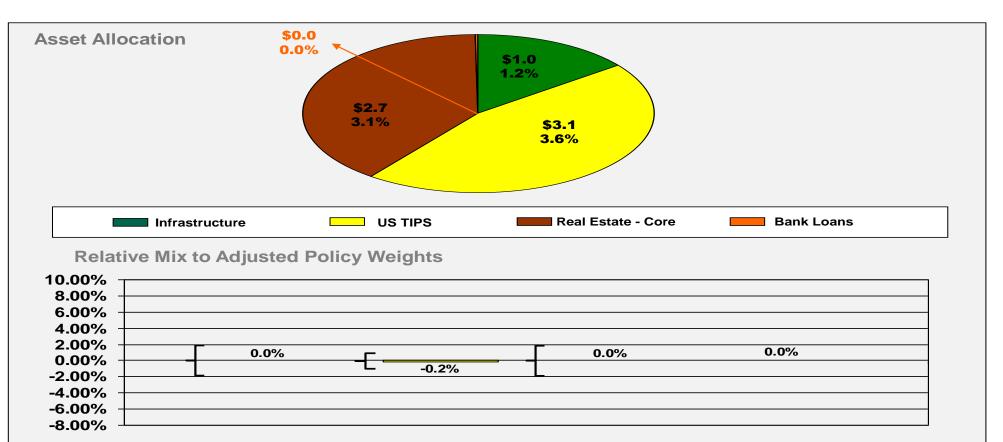


## **Portfolio Asset Allocation – Inflation Protection**

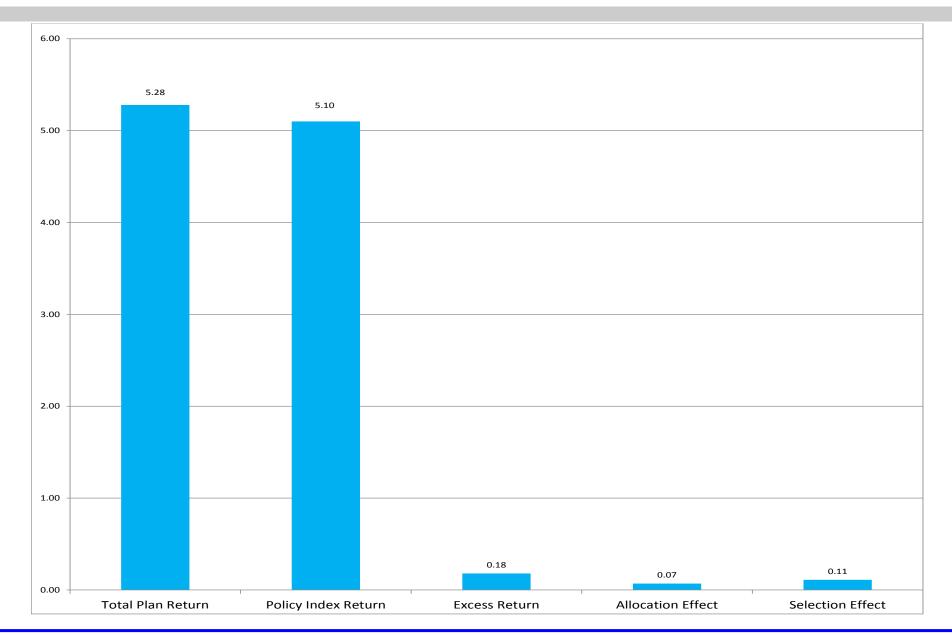

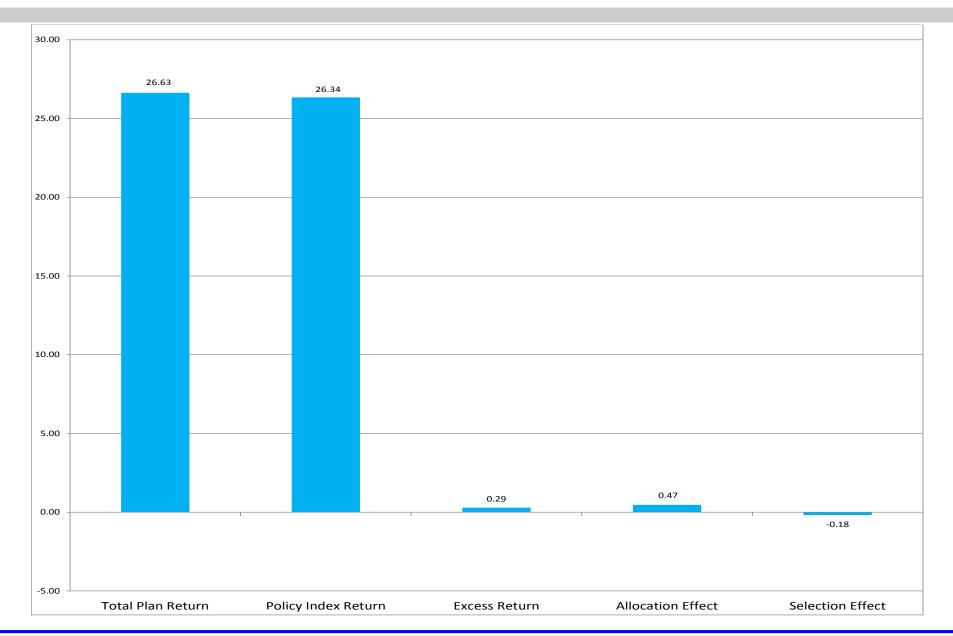

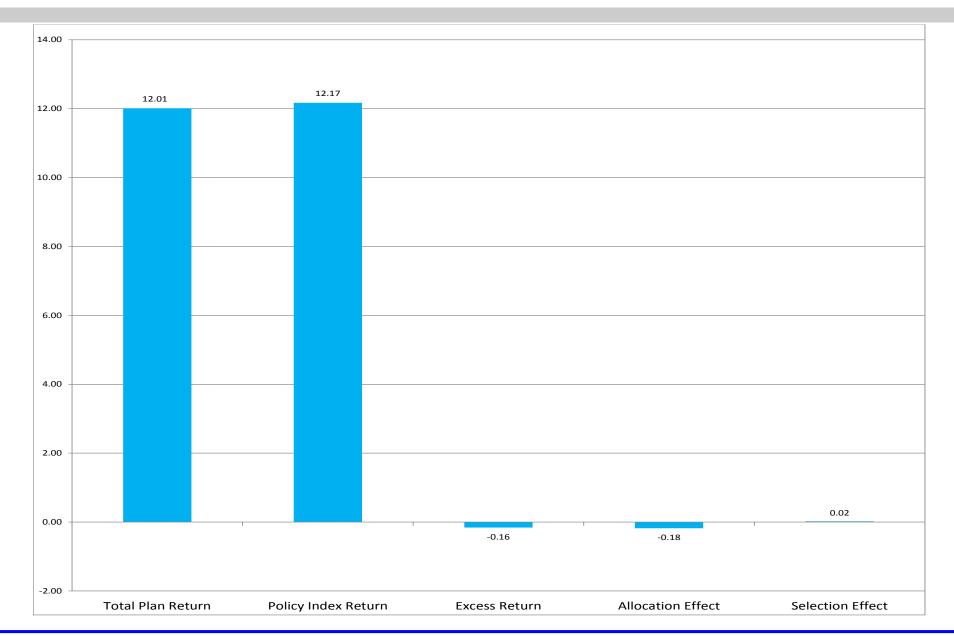
## Performance Attribution: Total Plan - Fiscal Year to Date: June 30, 2021





## Performance Attribution: Total Plan - 3 Years Ending: June 30, 2021



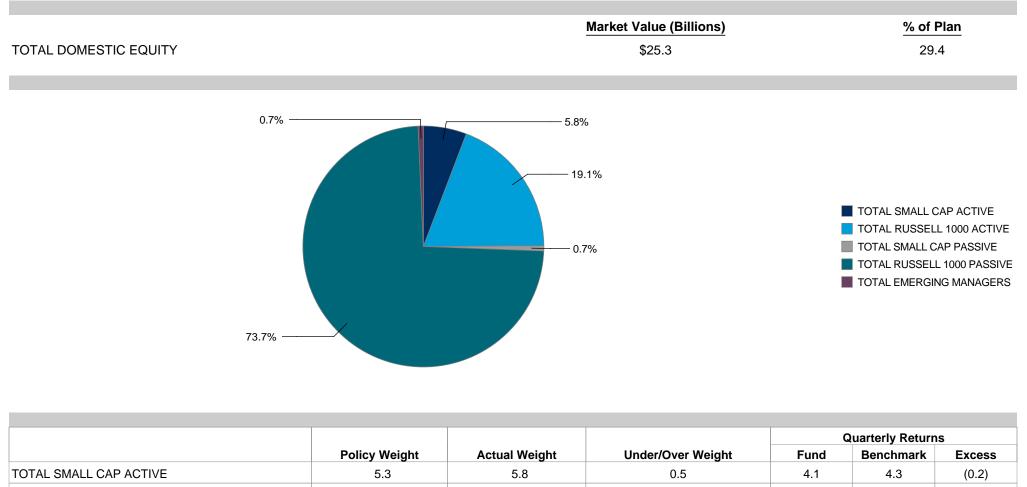

#### **General Notes**

- Estimated management fees for public market investments are calculated on an accrual basis without adjustment for management fee caps. Alternative investment (Private Market) fees are recorded on a cash basis and are not inclusive of carried interest paid. Since not all alternative managers currently provide detailed fee disclosure, the alternative investment fees noted here are not comprehensive.
- Returns greater than 1 year are annualized.
- Public Market returns are Net of Manager Fees for periods after January 2014 and Gross of investment advisory fees for other periods unless otherwise indicated.
- Public market excess returns for periods prior to 2014 are based on Gross performance.
