JOB DESCRIPTION

The Bureau of Information Systems & Technology (BIST) provides customer support and technology leadership for the Office of the Comptroller. Under the direction of a Senior IT Specialist for Network Services, and afforded latitude for independent judgment and decision making, the Network Infrastructure Manager responsibilities include, but are not limited to, the following:

- Understand, document and diagnose infrastructure issues especially VLAN, name resolution and bandwidth related:
- Perform and analyze packet captures to resolve connectivity and reliability concerns:
- Integrate new hardware and applications related to network and systems infrastructure;
- Research relevant hardware and software tools that will help ensure infrastructure performance and security; evaluate current cloud network strategy and identify potential improvements;
- Create reference architecture documentation to be used by technical support provided to customers;
- Serve as a virtualization lead specializing in VMware software defined Data Center (SDDC) solutions;
- Design, implement and maintain VMware vSphere 6.X and vRealize Automation environments;
- Identify network requirements in response to customer requirements, risks, and costs by working directly with management and system administrators;
- Translate complex technical requirements into actionable and sustainable tasks; and,
- Perform other related assignments and duties as may be required.
